GEFCU \$100 Mobile Check Deposit Contest Official Rules

Contest Time Period: Contest begins at 12:00 a.m. (central time) March 1, 2017 and will end at 11:59 p.m. (central time) March 31, 2017.

No purchase, payment or obligation necessary to enter or win.

Eligibility: The GEFCU \$100 Mobile Check Deposit contest is open to only members of GEFCU in good standing. Entrants must be 18 years of age or older as of March 1st, 2017. Void where prohibited. GEFCU employees, immediate family of employees, members of the Board of Directors and all committees are not eligible to enter the drawing.

To Enter: To enter the contest, members must use the Mobile Check Deposit feature in the GEFCU app to deposit a check into their GEFCU account. Each member will receive 1 entry for each check deposited remotely for the month of March posting to the account before 11:59 p.m. (central time) March 31st. No limit on entries.

Alternate entry: mail 3"x5" card with member name, phone number, address and account number to: GEFCU, PO Box 81535, Austin, TX. 78708. Alternate entries are limited to one entry each day per account. Copies not accepted. All entries must be received before end of business March 31, 2017. Entries missing information will be disqualified.

Prize: One \$100 GEFCU gift card

Odds: Odds of winning the prize depends on the total number of entries received during contest time period.

Sweepstakes Random Drawing: One (1) winner will be selected in a random drawing held on or about the April 3, 2017 from eligible entries. The winner will be notified by mail, phone and/or email the day of the drawing. Prize must be claimed within 30 days of notification or an alternate winner will be chosen.
